

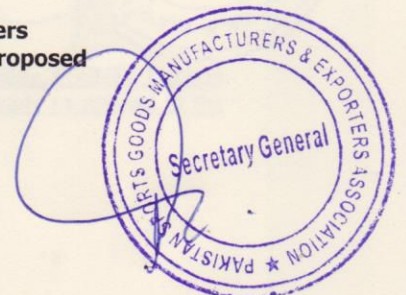

- 08.07.2017**  
(Saturday) Approval of Election Schedule by the Executive Committee.
- 10.07.2017**  
(Monday) i) Display of Election Schedule at Notice Board of the Association.  
ii) Intimation to the members through E-mail.  
iii) Submission to the Regulator.
- 11.07.2017**  
intimate  
(Tuesday) Last date for Member firms desiring to change their representatives shall changes regarding name of representative to the Secretary General along with necessary proof of eligibility.
- 15.07.2017**  
(Saturday) Display of Provisional List of all members eligible to vote alongwith their National Tax No., Sales Tax Registration No., (if applicable) the name and National Identity Card No. of the Representative.
- The list shall be:-  
a) displayed at the Notice Board of the Association and  
b) on website of the Association (www.psgmea.org.pk)  
c) Intimation to the members through E-mail.
- 22.07.2017**  
(Saturday) Last date for receipt of any objection in writing by the Secretary General from the members to the entries in the list of voters.
- 27.07.2017**  
(Thursday) Last date for intimation by the Secretary General of action on the objections or changes sent by the members.
- 31.07.2017**  
(Monday) Last date for making representation to the Election Commission by any person aggrieved by the decision of the Secretary General
- 03.08.2017**  
(Thursday) Last date for making decision by the Election Commission against the decision of the Secretary General.
- 05.08.2017**  
(Saturday) Last date for filing of appeal to the Regulator, by any person aggrieved by the decision of the Election Commission, or in case the Election Commission fails, to decide within stipulated time.
- 15.08.2017**  
(Tuesday) Last date for taking decision by the Regulator on the appeals, if any.
- 17.08.2017**  
(Thursday) Display of Final List of voters at Notice Board and intimation to them by E-mail & website as well as submission to the Regulator.
- Provided that if no appeal has been filed to the Regulator, the final list of voters shall be displayed within Fifteen days of the decision of the Election Commission Under Sub Rule (6).
- 21.08.2017**  
(Monday) Last date for receipt of Nomination Papers from the members eligible to contest the election for the vacant post, duly proposed and seconded by a duly registered voter and signed by the candidate, to the Secretary General.
- 22.08.2017**  
(Tuesday) i) Provision of a copy of the final list of voters to each contesting candidate.

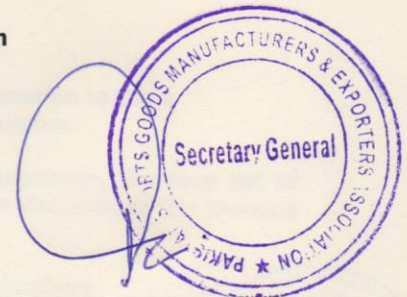

- 23.08.2017**  
(Wednesday) ii) Scrutiny of Nomination Papers by the Election Commission at 1100 hours in the Office of the Association and display of list of candidates.
- 24.08.2017**  
(Thursday) Last date for filing of objections, if any, to the nomination of candidates to the Election Commission.
- 26.08.2017**  
(Saturday) Last date for making decision by the Election Commission on the objections, if any, to the nomination of the candidates.
- 29.08.2017**  
(Tuesday) Last date for filing of appeal to the Regulator by any candidate aggrieved by the decision of the Election Commission or in case Commission fails, to decide within the stipulated time.
- 05.09.2017**  
(Tuesday) Last date for taking decision by Regulator against an appeal filed by an aggrieved candidate.
- 07.09.2017**  
(Thursday) Issuance of final list of candidates by the Commission within two days of the decision of the Regulator on appeals.  
-Provided that if no appeal has been filed to the Regulator, the final list of candidates shall be issued within 11 days of the decision of the Election Commission under -Sub Rule (12) of Trade Organization Rules 2013.
- 12.09.2017**  
(Tuesday) Polling for election of members of Executive Committee from Corporate & Associate Members shall be held at the registered office of the Association from 0900 hours to 1700 hours.
- 14.09.2017**  
(Thursday) Last date for filing of Nomination Papers to the Election Commission for election of Office Bearers duly proposed and seconded by an elected Executive Committee Member and signed by the Candidate.
- 15.09.2017**  
(Friday) Scrutiny of Nomination Papers by the Election Commission and display of final list of candidates.
- 18.09.2016**  
(Monday) Polling for election of Office Bearers shall be held during office hours.
- 27.09.2016**  
(Wednesday) Annual General Meeting, wherein final election results would be announced and:-  
a) displayed at the Notice Board of the Association within two days.  
b) Intimation to the members by E-mail within two days.  
c) Submission to the Regulator within 7 days.

**Note:**

If any of the Election Activity falls in the day which is officially declared as National/public holiday, PSGMEA Election Activity shall be done on the very next working day without disturbing the next activities already mentioned in the schedule.
